Format of the Forum

Roundtable Sessions

There will be three roundtable sessions over the course of the two days. Each session will focus on one of the three main topics of the Forum. Sub-topics will also be presented to help bring focus and relevance to the overall topic.

Roundtable Sessions (main topics and sub-topics):

- I. Faculty recruitment and retention (trends/hot areas, cross-institutional appointments, retirement policies, preparation of PhDs for academic careers)
- II. Interdisciplinary research, especially from an international perspective (international interdisciplinary collaborations, best practices, outcomes and success indicators and their measurements)
- III. Academic quality assurance for study abroad programs (student exchanges, short programs, fostering global-ready graduates)

Participants will be randomly assigned to a group for each roundtable session. This will allow for maximum interaction between all participants on topics of importance. Each participant will participate in the sessions and separate groups will discuss in parallel on the same overall roundtable topics and sub-topics.

Each roundtable session will be moderated by a participant of the forum. The first 30 minutes of each session will be given to the presentations of case studies and allow a maximum of three participants (10 minutes each) to share a case study on the topic or sub-topics at hand, within their respective institution.

Each group will then have 1 hour and 30 minutes to address any number of the sub-topics within the session. Groups may also discuss relevant issues outside of the sub-topics.

At the end of each roundtable session, groups will have the opportunity to share their findings during the plenary reporting session and present issues arising from their discussion with all participants. This portion will be led by the Chair of the plenary reporting session.
